The Animas Underground Water Rights Adjudication is before the Special Master on his own motion.



Moreover, the Court's Procedural Order Governing Expedited *Inter Se* Adjudication of State Law Water Rights, filed April 22, 2014, requires that all objections to a Proposed Judgment be filed on a form entitled "Notice of Intent to Participate in *Inter Se* Proceeding", a copy of which is attached hereto.

THEREFORE, the Special Master ORDERS THAT each person named above who wants to object to the Proposed Judgment shall file a Notice of Intent to Participate in Inter Se Proceeding with the Clerk of the Court within twenty days after service of this Order. The Special Master will recommend that the Court enter the Proposed Judgments, without further notice or hearing, if Notices of Intent are not filed by the required date.
